Evidence that shows that you are a member of the family unit of the New Zealand citizen. Dependants under 18 years	
For children travelling without one or both parents or legal guardians, provide: <ul style="list-style-type: none">• A copy of each non-travelling parent's ID card (showing photograph and signature); and• A completed Form 1229 from the non-travelling parent(s) giving consent for the child to migrate to Australia.	<input type="checkbox"/>

Dependants 18 years and over	
Evidence of financial dependency on the New Zealand citizen or the New Zealand citizen's partner for their basic needs of food, shelter and clothing, and how long this support has been provided.	<input type="checkbox"/>
Relationship Documentation	
If you are applying for a New Zealand Citizen family relationship visa on the basis of marriage, you need to provide a copy of your marriage certificate.	<input type="checkbox"/>
If you are applying for a New Zealand Citizen family relationship visa on the basis of a de facto relationship, you will need to provide evidence that you have been in the relationship, and living together for 12 months before lodging the application. Supporting documentation showing the genuine nature of relationship which may include: <ul style="list-style-type: none"> Copies of cards/letter which you have sent to one another including the envelopes Copies of telephone accounts showing phone calls made to each other A selection of coloured photocopies of photos together over the length of the relationship Copies of any money transfers between the couple showing a shared financial history Any other evidence of the relationship and its duration 	<input type="checkbox"/>

Penal (police) clearances for all applicants aged 18 years and over from each country in which the applicant has spent a total of 12 months or more in the last 10 years since turning 16 years of age.
